PASTOR'S REPORT

The old adage is that time flies when you are having fun, if that is the case I must be having a wonderful time as you pastor because I cannot believe that it has been two years since we began our journey together. I continue to overflow with thanksgiving to God for the opportunity to be your pastor.

One of the great joys this past year has been the number of new faces we have seen in this congregation. I never pastored a church that has had so many people stop in to worship with us, and better yet, they have kept joining us. As a church you all have welcomed them into our faith community as a part of the family. The warmth of this congregation and the way that you draw people into the life of the church is not common, and a true blessing.

It's been a blast to see this new part of our congregation fully embrace our church. They've been helping, serving, learning, and growing alongside us, and they've become such an integral part of our church family. I'm so glad I get to know them all!

For over a year now I have been leading a weekly adult Sunday School class. In 2024 we completed our companion study of The Story. We followed this by beginning a study based on the book Unoffendable. I've enjoyed the interactions that helping to facilitate this class brings.

I continue to help with CREW on Wednesday nights. I love getting to spend time with the kids that come to our weekly youth group, and to work alongside the wonderful adults who help with the program. As a part of my working with CREW, I have the teaching responsibilities.

On the denominational side, I am currently serving the larger church by moderating the Session at Medicine Lodge, KS, and I was appointed to the Permanent Judicial Commission (PJC). I have also regularly attended the meetings of the Presbytery either in person or via Zoom.

As a church, we experienced some staff transitions in the past year. Deb Pagenkopf, the chair of the worship committee, graciously stepped in to serve as the interim music director during the first part of the year. We were fortunate to have her creativity and passion for both worship and music. After Easter, she concluded her interim service.

In exploring our next steps, we decided to try a different approach. Brenda Johnson, our organist and keyboardist, offered to take on the planning responsibilities and coordination of the praise team. This solution seems to be working well.

Shannon Squires, our church custodian, ended her tenure. We are deeply grateful for the years she dedicated to keeping our church beautiful. We are equally blessed to have Bryce Corfee now maintaining the church's cleanliness and tidiness. He is doing an excellent job following in Shannon's footsteps.

Lastly, we discovered a genuine need for a nursery attendant. The church has been fortunate to have Audrey Burns join us. She has been wonderful working with the children and has also done an awesome job connecting with others in the church both before and after worship.

Andrea Stitt has continued to shine in her work as Communications Coordinator and Youth Director. God has been very good to us in bringing together such a wonderful Staff.

My deepest love in ministry is having the opportunity to share the good news, and as such, a significant part of my time is spent preparing for worship each week. In 2024, we completed our look at the story arc of Scripture and God's great redemptive plan. At the beginning of the school year, we began our next long sermon series, which is carrying us through the book of Acts, and how God calls us to be the

church, not just in the sanctuary on Sundays but to be the church in the world. We will continue this journey throughout 2025.

Thank you again for giving me the honor and privilege of being your pastor, of being my partners in ministry, and in sharing your lives with me. God is good indeed.

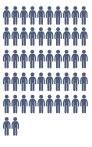

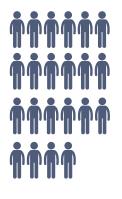

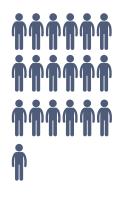


AVERAGE WEEKLY WORSHIP **ATTENDANCE**

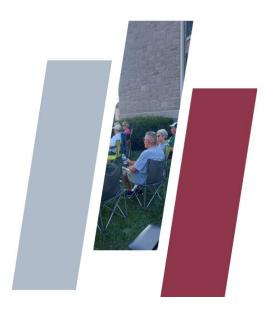

Deacons focused on those who were in the hospital or had an illness, new visitors and missing faces in worship. We set up a Greeter's Schedule so the church family could participate in welcoming people to church. Each week we set out a Thinking of You Card for the Church of the Week for the Church Family to sign. Each deacon has a Flock of 9-10 families.

Deacon Secretary, Pam Launchbaugh, has done a wonderful job tracking out activities and sending a monthly report to Session.

YOUTH DIRECTOR'S REPORT

2024 was a great year for growth in many ways for our youth. Our youth group added a new classroom for our 4th and 5th graders, breaking them off from the 2nd and 3rd graders. We added two new group leaders, Sue Griffith for 4th and 5th grade and C.L. Meigs for MS. We also added back our High School class which Carol Stull is now in charge of. Youth Day was started as a Church Worship Service. We began an Easter Egg Hunt Event for our church and the community. Our youth group participated in an end of year Talent Show where they all shared some of their amazing talents. We had our first Halloween Costume Party, which was Pirate themed and full of food, games and crafts. Lastly Movie Nights In The Sanctuary and Youth Day at the Pool were both created.

Our youth group's monthly activity nights began in January by taking the kids to the Rolla-Rena Skate-Center where they skated and enjoyed pizza. We went to the Teen Center in February, Wildlife and Parks Museum in March, and in April we had our Talent Show. To end the school year, in May we had hamburgers and hotdogs and played games at Lemon Park.

Other events included continuing our youth group Second Wednesday Sanctuary Message from Pastor Chris. One of these included attending the Ash Wednesday service. I put together our 2nd Annual Potluck Family Game Night in February for our church that was hosted in the Genesis Center. We had a small crowd but a great time gathering and playing games. An Easter Egg Hunt Event was organized on the south lawn of the Genesis Center. We had a great turnout for our first event and wonderful help from the congregation. For our Youth Day Service the kids did a great job of running the worship service, singing songs and performing a Parable Skit. We started our first Movie Night In The Sanctuary which followed our Youth Day rehearsal. In July I organized our annual pool party, where we had a great turnout with lots of food.

For our graduating seniors we provide them with Bibles to help them continue their faith journey. This comming year we will be working on bringing back confirmation were we will being giving those coming of age children a youth Bible.

We sent 22 youth to Westminster Woods Camp between our Church, Youth Group, and Eagle Wings. Congregants donated snacks for care packages. I created a bookmark using the camp themed scripture and gave each youth a gift for them to enjoy while at camp. We had several members of the congregation helping with transporting them to Eastminster where they caught the bus to camp.

Over the summer to stay engaged with our youth I put together a Youth Pool Day each Wednesday from 1:30-3:30 pm. This was a great chance to grow our relationships.

Our fall youth group session started out with even more changes. Each month we added a theme and focus that helped tie into our lessons. Themes included Sky, Pirate, and Railroad; all with decorations to supplement. I created four age teams where each team has a chance to earn points and win the team cup at the end of the school year.

We started celebrating birthdays at the beginning of each month. Birthday cards are now also being mailed to each youth, signed by members of our program. For a fun incentive to encourage positivity we give out stickers for acts of kindness. Once they reach 100 stickers they will have a fun reward.

For our youth group's activity nights in September we played yard games, in October we had our Halloween Costume Party, and in November we had our 2nd Annual Youth Served Thanksgiving Dinner that was attended by a great number of families and members of our congregation. We then decorated our Christmas tree. In December we had a Christmas Dinner and started a gift exchange which they seemed to really enjoy. We also went on our hayrack ride and served hot chocolate and candy canes.

Each month I like to give time to meet outside of Wednesday nights with either a social event or a community service act. We kicked off the school year with Blessing of the Backpacks by Pastor Chris for twelve of our youth. Several other opportunities ncluded a September Movie Night in the Sanctuary, attending the Ryan Stevenson concert, going to our Church Fall Festival at the Stull Farm, helping check lightbulbs for Lemon Park lights, and putting up the Nativity Scene for Lemon Park Lights. Our final event was our Christmas pageant "Twas The Night Before Christmas" during Sunday service on December 15th which was our biggest worship attendance of the year with 83. They also enjoyed a Movie Night In The Sanctuary following their Christmas Pageant dress rehearsal.

This year our youth participated in the Vernon Filley Annual Festival of Trees Wreaths and Decorations by creating ornaments for a Christmas tree that was on display during the holiday season. The ornaments were all handmade and depicted stars and people of the nativity; wise men, the Holy family, and angels.

As part of our youth group on Wednesday nights we serve supper. Many people from the congregation along with myself help with making meals and desserts. We have several who also help to serve the meal on Wednesdays.

I am also in charge of running our Sunday School program. I started the year in February by offering Sunday School at 9:00 am on the first, third and fifth Sundays of the month. This is offered for PreK4-5th grade. Our lessons started with a Kids of the Bible Series, then we moved onto a Life of Moses Series, and finished the year with a Wonders of the Bible Series. All year we have been working on learning the books of the Bible and are making our way through the Old Testament. Ideally for the coming year I would like to offer Sunday School the 2nd and 4th Sundays as well.

As part of my communications duties I shared an education devotional that was sent in our weekly newsletter. These devotionals had a different monthly theme that was to help the congregation engage with others as well as allow themselves to grow.

Nov – Hanging of the Greens was November 24 and we served chili and sides to those who helped with the decorating. We also helped with food for the CREW Thanksgiving dinner which included the church family.

Dec – We helped Mission and Outreach with providing boxes of cookies to deliver to people that worked on Christmas Eve. We also helped deliver the cookies.

FINANCIAL STEWARDSHIP

For the year 2024 the Financial Stewardship Team (FST) tracked contributions and expenses monthly for both general operations and benevolence. Reports were prepared and submitted to Session on a regular basis.

Contributions held up well during 2024 while expenditures were again below budget. General Fund transfers from the Financial Secretary were 10.7% above the budgeted amount. Expenditures were 7.3% below budget. During the late-summer and early-fall work was done on our 2025 budget which was reviewed and approved by the Financial Stewardship Team and subsequently adopted by Session. Said budget was presented to the congregation at large during an informational meeting during late-October.

Financial Stewardship Committee: Alan Waites as Session Member and Chair, Gordon Stofer as Church Treasurer, Don Peters as Special Funds Treasurer, and Linda Loomis as Financial Secretary. Pastor Chris Davis also participated in our meetings.

MISSION and OUTREACH

ONGOING EVENTS AND ACTIVITIES

Friendship Meals – Our church has been delivering meals on Thursdays to shut-ins for more than 50 years. We originally did this through the hospital Meals-on-Wheels program and then when that program stopped, we began delivering through the Pratt County RSVP Friendship Meals program. We especially want to thank Dona Cochran and Bonnie Stofer for their many, many years of delivering meals.

Jail Ministry – Our church prepared a wonderful homemade holiday meal for Easter and Christmas and delivered those meals to the Law Enforcement Center for the inmates and staff. Our committee picked up Thanksgiving meals prepared and packaged by volunteers from the Community Thanksgiving meal and delivered those to the inmates and staff. Thank you to Tara Pagenkopf and the many volunteers who make this possible.

Minute for Mission – Our team promoted every Special Offering and designated that 25% of the Peace & Global Witness offering be combined with last year's offering toward a mission trip. We also promoted opportunities for the congregation to be involved in mission projects such as Circles Meals, Souper Bowl Sunday, Noisy Cans and Fish Banks, camp care package donations, and Mission Tree projects.

Circles Anti – Poverty Program at FUMC - Our church is on a quarterly schedule to provide meals that fed approximately 45 participants each month. However, with a new person scheduling, we were omitted a time or two but have 4 dates set up now for 2025.

Cookies to church Visitors – The M&O committee delivered cookies to 11 family units who had visited church at least two times. Nine of those family units have continued to attend or return to worship.

Transient Food Bags – M and O is using money from our budget to purchase non-perishable food items to have available when occasionally an individual stops by the church or Genesis Center in need of some food. We are enclosing business cards from the HOPE Center, Agape Clinic and Circles. One visitor benefitted this year from our Transient Bag. The remaining food items were added to the camper boxes before they expired.

Parking Lot Greeters – Our team was responsible for one month of greeting guests outside.

Schools – Our committee delivered 38 pairs of socks and 6 sweatpants donated from our church Mission Tree to the Southwest school nurse.

Visitation Sheets – Our team is responsible for picking up the visitation sheets and getting that information to our team, Andrea and Pastor Chris, and the Deacons.

SPECIAL EVENTS AND ACTIVITIES

Souper Bowl Sunday - Our team decorated boxes for people to 'vote' for their favorite Super Bowl team with food donations for the Pratt County Food Bank. Bill and Cindy Keller delivered 55 pounds of food from the Chiefs' box and 0 pounds from the 49ers' box. A 'W' for the Chiefs and Food Bank!

Project Prom – This year M&O donated \$25 to both Skyline and Pratt High After Prom Parties.

Westminster Woods Camp – We organized church members to help pack camp care packages. Anne and Carol, along with Andrea, one parent, and Pastor Chris, transported camp kids to and from Eastminster Church since Westminster Woods did not provide bus transportation this year.

Fall Festival – The Fall Festival was a great success. The weather was beautiful, and we had 65 in attendance. This year instead of playing games, we stopped at Buford and Pam Johnson's Halloween Trails halfway through the hayride. Some of the kids helped decorate and take down the decorations and acted as guides for the group. Kids also helped with the spooking.

Centering Prayer – M&O initiated a Centering Prayer group. We have had several gatherings and are hoping that we can help other interested people create small groups of 5 to 7 people to meet weekly for Centering Prayer. Please visit with Anne, Pam, or Carol if you are interested. You can go to www.contemplativeoutreach.org to find out more about this method of silent prayer which deepens our relationship with God.

Christmas Mission Tree – This year our congregation donated fruit, candy or money towards purchasing fruit, candy, and meat sticks that were donated to Eagle Wings children and their siblings. Everyone was very generous. On Christmas Eve morning, Anne and Carol delivered 10 boxes of goodies for 21 children. The parents were so appreciative.

Lemon Park Lights Nativity Display – Our church is one of several that donated to the purchase of the Nativity Scene which is placed on the PCC softball diamond at Lemon Park. But our church is the group that sets up and takes down the display each year. Some years the weather is a real challenge. We had wonderful help and participation this year.

Cookies to Christmas Eve Night Shift workers – This year Pastor Chris brought a new idea for our church to session. He even purchased cookie boxes and Andrea created a beautiful card that went with the delivery. Our church members baked and delivered cookies to 17 businesses that stayed open all night on Christmas Eve. Most of the people receiving the cookies felt very appreciated and warmed by our gesture. This may become an annual event.

PROPERTIES

The Property Committee for 2024 consisted of Rex Johnston, John Cochran, Gordon Stull, Frank Hopkins, Gary Slief, and Bill Keller, as Chairman. Pastor Chris Davis was also actively involved in committee meetings and activity.

Fortunately, we did not suffer any serious storm damage like we incurred in 2023. The repair work from the storm damage carried into 2024, as Mainstream Roofing and Pratt Glass did their repair work in the 2024 year. Our casualty insurance coverage paid our claims off in 2024.

We had Work Days on May 18, 2024 and October 5, 2024. Both Work Days were well attended by our congregants, and we accomplished a lot of work in various areas of need. Through the work done on our two Work Days, work done by the committee and others at other times, and work done by various contractors hired by the committee, we accomplished the following:

- Replace the water heater in the Genesis Center.
- Servicing of the HVAC systems.
- Reorganization of the Bridal Room in the basement Ladies Room.
- Install occupancy-sensor switches in the Genesis Center.
- Purchase and install a new freezer in the Church basement.
- Re-keying of doors.
- Patch cracks, repave, and stripe the parking lot.
- Trim tree on the northside of Genesis Center.
- Clear and clean sidewalk on the northside of Genesis Center.
- Fix drainage problems with underground drainage pipes from Church rain gutter.
- Install underground conduit and wiring to rewire Church Tower exterior light fixture.
- Repair loose siding on Genesis Center.
- Check and clean all rain gutters.
- Work on drainage problems at the NE corner of the Church to solve water problems.
- Repair of light fixtures and replacement of light bulbs.
- Remove old window air-conditioner from Genesis Center.
- Replace roof on exterior entry for elevator.
- Purchase and install a TV monitor in the sanctuary.
- Trimming of bushes.
- Fix leaking toilets.

The following issues are on our list for future projects:

- Determine the best way to refurbish and protect the wooden window frames in the Church. A number of them need attention.
- Devise a way to improve drainage away from the north basement wall of the Church.
- Repair the ceiling in the Tower Room.
- Repair water damage to the wall in the Orchard Room.
- Replace the carpet on the entryway steps at the SE corner of the Church.
- Figure out a way to prevent rainwater from a wind-driven storm from blowing into the exterior stairwell on the north side of the Church.
- Install new programmable thermostats for the Church to give us better control over the HVAC system usage.

The Church owns two buildings, one of which is over 100 years old. We will always have maintenance issues to address, but our committee and our congregation have always been willing to do the work and meet the expenses to maintain our property so that it serves the mission of the Church. We are fortunate to have so many of our members step up and help us when work needs to be done. As Chairman of the Property Committee, I want to thank the committee members and the congregation members for all of the work that we have accomplished in maintaining and improving our facilities.

We continue to keep those kids in our program and as a result I spend more time with the kids individually and watching their sports, concerts, and programs. I attended football, wrestling, tennis, basketball, band and vocal concerts, and graduation. Usually, it has been more difficult to find mentors than kids for the Eagle Wings program. However, this year it has been the opposite. I have trained 6 mentors and matched one of those. Another match is in process. I had a phone meeting with the Wichita CAYM director. I met with 8 prospective mentors and met or communicated with Skyline, Southwest, PAC and Liberty administrators, teachers, and counselors. This year will be focused on getting kids in the program which has never been a challenge before this year.

The year started with the Nativity display being taken down with lots of snow on the ground. We were hoping to have airplane rides this year but we will need to wait till 2025. Thank you to Alan Luttrell for hooking me up with the pilot. In May, our church packed camp boxes with donated snacks. The end of May and month of June was busy with campers. I applied for camp scholarships, provided Bibles, flashlights, toiletry items as needed, and this year Andrea, Pastor Chris, a parent and I hauled kids to and from Eastminster Church in Wichita since no buses were provided for the Western Kansas campers. All of June was busy with our scrap metal collection projects. On Fridays, we set up a dump truck on the church parking lot for people to drop off donations and then other days we hauled the dump truck and a flatbed trailer to pick up donations. EWM kids and mentors helped monitor the dump truck and load the trailer. A check for \$2,560.78 was donated to Rolla Rena. They were able to install a portion of sidewalk and 2 wheelchair ramps. It was such a fun project. The kids enjoyed doing physical labor. Thank you to all of those who donated items and loads of metal to the project. In July, we combined with the church for the Pool Party. It was a great success and Andrea did a wonderful job organizing it. When CREW started up, I began a small High School class that is using Brian McLaren's book, 'We Make the Road by Walking.' In September we had a group activity at PCC to watch the women play Volleyball. In October, we had the Fall Festival. It was great weather and was attended by 65 people. Pam and Buford Johnson invited us to walk their Halloween trails halfway through our hayride. Mentees helped decorate the trails and dressed as witches to guide guests. Mentees also helped with our spooking. The kids returned after the weekend to help remove decorations at Johnson's. As November rolled around, our group assisted church members in setting up the Lemon Park Lights Nativity. On Christmas Eve morning, Anne Loomis and I delivered stocking fruit, candy and meat sticks to the Eagle Wings kids and their siblings. The donations were from our church mission tree project and were greatly appreciated. As always, this program would not flourish without our faithful mentors, match superintendents and the support and encouragement of our church family. Please keep these kids and this ministry in your prayers.
